COMBO CAMP Ages 4 – 8

Monday - Friday, 9 am - 3:00 pm (9 am - 12:30 pm at CRCC / 12:30 - 3:00 pm at St. Marks)

Pricing: Member \$410 Non-Member \$440

Combo Camp introduces students to tennis, golf and swimming! Every Monday - Thursday the children start their day with tennis from 9 - 10 am followed by outdoor play on Monday and golf Tuesday through Thursday from 10 - 11 am. Lunch is from 11 - 11:30 am and is followed by swimming. On Fridays, the children start their day with golf and the standard schedule of outdoor play, lunch and swimming resumes.

JUNIOR GOLF CAMP Ages 5 – 8

Monday - Friday, 9 am - 3:00 pm (9 am - 12:30 pm at CRCC / 12:30 - 3:00 pm at St. Marks)

Pricing: Member \$450 Non-Member \$490

Jr. Golf Camp (Tuesday – Friday) begins with practice range and training station rotations, cool down/snacks followed by course instruction and games. Lunch is from 11 - 11:30 am and is followed by review and prizes. Monday will be Tennis camp.

Drop-off is at CRCC by 9 am. Go through the Playground Gate to the Terrace (follow signs)

Campers are picked up by bus and spend the rest of the day in St. Marks. Pick-up is at St. Marks at 3:00 pm.

CAMP POLICIES

Weather Policy: In the case of inclement weather while campers are at Coral Ridge C.C., camp directors make every attempt to keep the campers busy indoors. However, if rain is persistent, campers will be picked up by bus and will spend the remainder of the day at St. Marks.

Drop-off & Pick-up: All child(ren) must be signed in and out of camp by their parent or guardian. Please do not drop-off your child(ren) early because we are not set-up for childcare before camp hours. We ask that you DO NOT drop-off your children more than 10 minutes before the camp start time.

Camp Registration: A completed registration/waiver form is required before your child can attend camp. Payment is required before camp begins each week and two weeks advance notice is required to hold your child's spot. NO REFUNDS.
